SCPOA Standing Rule 10-003

The Board of Directors has adopted safety range rules for each range. All members shall follow these range rules and, if necessary, ensure other members will also follow the rules.

Failure to follow the range rules may result in suspension or termination from membership, pursuant to Bylaws, Section II, Members, Termination and Suspension

RANGE 1

- MEMBERS ONLY.
- GUEST(S) MUST BE WITH MEMBER.
- RANGE OPEN DAILY 0700 – 2200 HOURS ONLY.
- ALL PORTABLE TARGETS SHALL BE PLACED WITHIN 15 FEET OF RAISED THE 100 OR 200 YARD DIRT TARGET BANK.
- NO CLAY OR GLASS TARGETS.
- DO NOT SHOOT INTO THE AIR OR GROUND.
- NO ALCOHOL ON RANGE AT ANYTIME.
- NO RIDICULOUS BEHAVIOR.
- NO VEHICLES ON RANGE AT ANYTIME.
Unloading/Loading and Law Enforcement exempted
- NO CHILDREN ON RANGE UNLESS SUPERVISED BY A MEMBER.
- EYE AND EAR PROTECTION REQUIRED.
- PICK UP AND RECYCLE YOUR BRASS CASINGS.
- PICK UP AND DISPOSE OF YOUR TARGETS.
- PICK UP AND DISPOSE OF YOUR TRASH.
- ON-DUTY LAW ENFORCEMENT AGENCIES HAVE PRIORITY WITH RANGE USE.
- REPORT ANY PROBLEMS OR ISSUES TO ANY BOARD OF DIRECTOR.
- VIOLATIONS TO SCPOA RULES MAY RESULT IN REMOVAL FROM THE RANGE AND POSSIBLE SUSPENSION FROM MEMBERSHIP.

RANGE 2

- MEMBERS ONLY.
- GUEST(S) MUST BE WITH MEMBER.
- RANGE OPEN DAILY 0700 – 2200 HOURS ONLY.
- ALL PORTABLE TARGETS SHALL BE PLACED WITHIN 15 FEET OF THE 25 YARD RAISED DIRT TARGET BANK.
- NO RIFLES, SHOTGUNS OK Law Enforcement exempted

RANGE 3

- MEMBERS ONLY.
- GUEST(S) MUST BE WITH MEMBER.
- RANGE OPEN DAILY 0700 – 2200 HOURS ONLY.
- ALL TARGETS SHALL BE PLACED ON TARGET MOUNTS.
- PAPER TARGETS ONLY
- DO NOT SHOOT INTO THE AIR OR GROUND.
- NO ALCOHOL ON RANGE AT ANYTIME.
- NO RIDICULOUS BEHAVIOR.
- NO RIFLES OR SHOTGUNS, NO EXCEPTIONS
- NO VEHICLES ON RANGE AT ANYTIME.
Unloading/Loading and Law Enforcement exempted
- NO CHILDREN ON RANGE UNLESS SUPERVISED BY A MEMBER.
- EYE AND EAR PROTECTION REQUIRED.
- PICK UP AND RECYCLE YOUR BRASS CASINGS.
- PICK UP AND DISPOSE OF YOUR TARGETS.
- PICK UP AND DISPOSE OF YOUR TRASH.
- ON-DUTY LAW ENFORCEMENT AGENCIES HAVE PRIORITY WITH RANGE USE.
